## BUS SAFETY INFORMATION

### Parent and Student Tips

- Get to the school bus stop five minutes early, so you won't have to run across the road to catch the bus.
- When waiting for the bus, stay away from traffic. Line up at least five steps away from the curb or the roadway to wait for the bus.
- Never run after the school bus if it has already left the bus stop.
- Never push when getting on or off of the school bus.
- Always walk at least 10 feet in front of the bus when crossing so that the school bus driver can see you.
- Be aware Cross with Care! Wait until the school bus has stopped all traffic before stepping out onto the road.
- When the school bus is moving, always stay in your seat. Never put your head, arms or hands out of the window.
- Talk quietly; do not distract your school bus driver.
- If your school bus crosses railroad tracks, be calm and quiet so that your driver can listen for a train. Always obey your school bus driver's instructions, so that he or she can make safe decisions.
- Never play with the emergency exits. Backpacks, band instruments, or sports equipment may not block the aisle or emergency exits. If there is an emergency, listen to the driver and follow instructions.
- When getting off of the school bus, make sure that all drawstrings and other loose objects are secure so that they don't get caught on the handrail or the door.
- Never cross the street behind the school bus.
- If you leave something on the bus or drop something outside of the bus, never go back for it. The driver may not see you and begin moving the bus.
- Never speak to strangers at the bus stop and never get into the car with a stranger.

## Supervision of Kindergarten Students

The District requires a parent/guardian to accompany a kindergarten student to and from bus stops or to and from school buildings at all times. A parent/guardian may authorize another responsible adult to accompany, pick up or drop off a kindergarten student at a bus stop, by completing a "Responsible Adult Designation Form for a Kindergarten Student." The Transportation Department will contact the parent/guardian with an effective date for the responsible adult designation, which is generally within 48 hours after receipt. If a parent/guardian or an authorized adult is not present to meet and accompany a kindergarten student at the designated bus stop, the driver is required to return the student to his/her school building. The parent/guardian will be responsible to pick up the child at the school building. If a kindergarten student is returned to his/her school building three (3) times, transportation privileges may be suspended.

# **Operation Safe Stop**

Operation Safe Stop is a proactive approach to educating the motoring public that passing a stopped school bus when children are loading or unloading is both dangerous and illegal. Law enforcement agencies, school transportation providers, pupil transportation associations, and Penn DOT have combined their efforts to raise public awareness about the potential consequences of illegal school bus passes and to reduce their occurrence.

On highways or traffic-ways not separated by a physical barrier, traffic in all directions must stop at least 10 feet away from the bus and remain stopped until every child has entered the bus (when loading) or has reached the sidewalk or side of highway (when unloading). Painted center lines, dividers, or a center turning lane do not create separate roadways. All traffic must stop on highways with these markings.

On highway or traffic-ways separated by a physical barrier, traffic moving in the same direction as the bus must stop as described above. Traffic approaching the bus from the opposite direction may proceed with caution. A highway with separate roadways is divided into two or more roadways with physical barriers such as concrete median barrier, metal median barrier, non-mountable curb or clearly indicated dividing sections (e.g. concrete mountable curb, trees or shrubs, rock or boulders, steam grass) to block traffic between the roadways. The driver of a vehicle approaching an intersection where a school bus is stopped to load or unload students must stop the vehicle at the intersection until the flashing red signal lamps are no longer actuated.

Student Operation Safe Stop training is held annually in the month of October.
